How Software Licensing Works

Software licensing provides increased scalability and rapid deployment of hardware and software features on the supported RUCKUS family of switches. One or more valid software licenses are required to run licensed features on the device.

A permanent license (for select features on specific units) can be ordered pre-installed on a RUCKUS device when first shipped from the factory, or later ordered and installed by the customer. In either case, additional licenses can be ordered as needed.

When a license is ordered separately (not pre-installed), an entitlement certificate or email message, along with an Activation Code, are issued to the customer by RUCKUS as proof of purchase.

After a license is installed on the RUCKUS device, the license unlocks the licensed feature and the feature becomes available immediately. There is no need to reload the software.

Self-Authenticated Upgrade Licensing

Self-Authenticated Upgrade (SAU) licensing allows you to upgrade or downgrade to a licensed feature set with a single command. The **license install** command replaces other licensing commands for installing or deleting a license. You no longer need to install a license file using TFTP or SCP.

Software Licensing Terminology

The following terms are used in this document:

- Activation Code: A unique key, along with the serial number, used to generate a CoE on the Ruckus Support site. The Activation Code is issued by RUCKUS when a license is purchased. The Activation Code is delivered in an email message a few minutes after the order is placed, though the timing will vary depending on the network, Internet connection, and so on.
- Certificate of Entitlement (CoE): The proof-of-purchase certificate issued by RUCKUS when a license is purchased. When a license is purchased, an Activation Code is sent to the customer by email. This Activation Code and the target device serial number are needed to create the CoE, which has its own unique serial number and is downloaded as a PDF file from the Ruckus Support site. One CoE is issued for each feature license that is purchased. The CoE serial number can be entered on the switch using the license set command, which causes the CoE serial number to be displayed in show command output and available through SNMP.
- Licensed feature: Any hardware or software feature or set of features that require a valid software license to operate on the device.

Licensing Rules

The following licensing rules apply to all ICX devices that support SAU software licensing:

- A license is not tied to a specific device. It can be removed from one device and redeployed on another device.
- More than one license can be installed per device concurrently.
- Licensed features can be activated prior to obtaining a valid license and used for a trial period of 45 days, based on an agreement to obtain a license.
- Trial licenses for all licensed features are built into the device. Enabling any licensed feature activates a 45-day trial period requiring acceptance of the Ruckus terms and conditions of use.
- More than one trial license can be in effect at the same time, as long as each trial license applies to a unique licensed feature.
- A trial license cannot replace or supersede a normal license.

FastIron Licensed Features and Platform Support

Some RUCKUS ICX devices come with feature licenses pre-installed. For devices that do not have pre-installed licenses, you can purchase licenses separately for the features or feature sets you want to use.

The following table lists the licenses that are available for each Ruckus ICX platform. Note the following descriptions of the fields:

- Licensed Feature: Licensed features available for the platform.
- License Install Options: Names of the licenses that can be installed on the platform. These are the license names used in the CLI when installing a license. Note that the "R" in the license name indicates the L3 PREM license.
- License Delete Options: Names of the licenses that can be deleted from the platform. These are the license names used in the CLI when deleting a license.
- Default Package: Pre-installed licenses on the platform.
- **Possible Packages**: Possible license packages available for the platform. These license package names are displayed in the **show license** command output.

Upgrading from FastIron 08.0.70 and Earlier Releases

Beginning in FastIron 08.0.80, the Self-Authenticated Upgrade (SAU) licensing model was implemented on all the RUCKUS ICX platforms. When upgrading from FastIron 08.0.70 or earlier releases, existing software feature licenses on the device will be converted to SAU licenses. The original XML licenses are preserved on the system in case the switch is downgraded to an earlier version that requires them.

Upgrade Considerations for the Layer 3 Premium License

In FastIron 08.0.70 and earlier releases, Layer 3 Premium licenses on the ICX 7250 and ICX 7450 were implemented as XML licenses. Beginning with FastIron 08.0.80, all Layer 3 Premium licenses are Self-Authenticated Upgrade (SAU) licenses.

Upgrading a System Without a Layer 3 Premium License from FastIron 08.0.70 or Earlier Releases

Layer 3 Premium licensed features are not available until the user has enabled the Layer 3 Premium SAU license. Without the Layer 3 Premium license, the Layer 3 licensed features cannot be used. This is a change in behavior for the ICX 7250 and ICX 7450; in releases prior to FastIron 08.08.80, licensed Layer 3 features could be enabled before a license was installed.

In an upgrade from FastIron 08.0.70 or earlier releases to FastIron 08.0.80 or later releases, the system enables the Layer 3 Base license package automatically, which means all Layer 3 premium features are disabled.

However, if the system does not have a Layer 3 Premium XML license and Layer 3 Premium features are configured, these L3 features will be lost after the upgrade. In order to avoid losing Layer 3 configurations, perform one of the following actions before or after the upgrade:

- Before upgrading the system, check the license compliance status. Purchase and install the Layer 3 Premium XML license on the device if needed. Always back up the configuration, and keep a backup of all license files.
- Before upgrading the system, back up the configuration. After the upgrade, enable the Layer 3 Premium SAU license and copy the configuration back to the system.
- After upgrading the system, immediately enable the Layer 3 Premium SAU license, but do not save the configuration, and then reload. After the system is back up, the Layer 3 Premium configuration should be back as it was before the upgrade.

NOTE

In this case, the running configuration is lost, but the Layer 3 premium configuration remains in the startup configuration as long as the user does not enter the **write mem** command after the upgrade.

Upgrading from FastIron 08.0.70 and Earlier Releases

In a stacking configuration, if Layer 3 licensed features are required then a valid Layer 3 Premium license must be installed on all members of the stack.

If the active unit has an XML Layer 3 Premium license installed, the Layer 3 Premium configuration should remain the same after the upgrade, but member units without a Layer 3 Premium XML license will enter a non-operational state. To prevent member units from becoming non-operational, copy the Layer 3 Premium XML license to relevant units before the upgrade, or enable the Layer 3 Premium SAU license on relevant units after the upgrade.

If the active unit does not have a Layer 3 Premium XML license, the configuration of any premium Layer 3 features will be lost after the upgrade. Use one of the three preceding methods to prevent the loss of or to recover the Layer 3 configuration.

ICX Device with an Existing Layer 3 Premium XML License

If there is an existing Layer 3 Premium XML license on the device, the system will automatically enable the Layer 3 Premium SAU license upon upgrade to 08.0.80, and Layer 3 feature configuration will be retained. All Layer 3 features will function as before the upgrade.

All XML license files will be preserved in case the device is loaded with a non-SAU license image (that is, in case of a downgrade).

Upgrade Considerations for Ports on Demand Licenses

In FastIron 08.0.70 and earlier releases, Ports on Demand (PoD) licenses on the ICX 7250 were implemented as XML licenses. Beginning with FastIron 08.0.80, all PoD licenses are Self-Authenticated Upgrade (SAU) licenses.

Upgrading an ICX 7250 Without an XML PoD License

Without a PoD license, all the licensed ports on an ICX 7250 have 1-Gbps speed. After an upgrade to 08.0.80 or later releases, these ports will continue to have 1-Gbps speed. If a user needs a 10-Gbps port after the upgrade, user can enable the PoD SAU license for the 2x10G or 8x10G option.

Upgrading an ICX 7250 With an Existing XML PoD License

When an ICX 7250 with an existing PoD XML license is upgraded to FastIron 08.0.80 or later releases, the system automatically converts the PoD XML license to the corresponding PoD SAU license.

An upgrade to 08.0.80 has no impact on a stacking system.

When a user sets the PoD SAU license, the system looks at the existing XML license. If the option selected is of an equal or lower capacity to thePoD XML license, the SAU license is enabled. If an option with a higher capacity that the PoD XML license is selected, the SAU license is not enabled and the system displays a message instructing you to delete the PoD XML license before enabling the SAU license.

All XML license files will be preserved in case the device is downgraded to FastIron 08.0.70 or earlier release.

Upgrade Considerations for MACsec Licenses

In FastIron 08.0.70 and earlier releases, MACsec licenses were implemented as XML licenses. Beginning with FastIron 08.0.80, all MACsec licenses are Self-Authenticated Upgrade (SAU) licenses.

Upgrading an ICX 7450 or ICX 7650 Without an Existing MACsec License

A MACsec license is required to enable MACsec encryption on a port. When upgrading from FastIron 08.0.70 or earlier releases to FastIron 08.0.80 or later releases, if there is not an existing MACsec XML license on the switch, the MACsec SAU license will not be enabled after the upgrade.

Upgrading an ICX 7450 or ICX 7650 With an Existing MACsec License

When an ICX 7450 or ICX 7650 with an existing MACsec XML license is upgraded to FastIron 08.0.80 or later releases, the system automatically converts the MACsec XML license to the corresponding SAU license.

An upgrade to FastIron 08.0.80 or later releases has no impact on a stacking system.

Software Licensing Configuration Tasks

Software licensing configuration tasks require generating and obtaining a software license, and then installing the license on the RUCKUS device. The following tasks must be performed in the order given.

- 1. Order the desired license.
- 2. Retrieve the serial number of the RUCKUS device and the license Activation Code, which will be delivered by email.
- 3. Log in to the RUCKUS Support portal (https://support.ruckuswireless.com) to generate the CoE.
- 4. Install the SAU license on the RUCKUS device, and optionally add the CoE serial number.
- 5. Verify that the license is installed.

Generating a Certificate of Entitlement

You must generate the Certificate of Entitlement (CoE) from the RUCKUS Support portal before you can install your SAU license.

You need the following information to generate a CoE:

- Activation Code
- Serial number of the device
- Support account

Perform the following steps to gather the necessary information and generate a CoE.

1. Order a license CoE.

After ordering the license, an Activation Code will be sent to you by email.

NOTE

45-day trial licenses are built in to the device and available by default.

NOTE

Do not delete the email message with the electronic Activation Code until the CoE has been generated, in case it is needed for technical support.

2. Enter the **show version** command on your Ruckus device to find the serial number.


FIGURE 3 Activating Your Support Contract & License Code Window

See the *RUCKUS FastIron Software Licensing Guide* for your release for instructions on uploading the license file.



Installing and Downgrading SAU Licenses

- 4. Depending on the status of the license (for example, whether or not the license was generated), the report includes the following product information:
 - Product name SKU
 - ID value
 - Activation Code
 - License
 - Created date
 - Capacity
 - Customer name
 - Description

If the query is performed before the Activation Code is generated, the hardware-related information will not appear as part of the search results. Similarly, if the query is performed before the license is generated, some of the information in the software-related information will not be displayed.

- 5. Click more or less in ID value to view the serial number.
- 6. Click the License hyperlink to download the license information.
- 7. Click Export to Excel to download the report for sharing or archiving purposes, or click Search Another Unit to query another product.

Installing and Downgrading SAU Licenses

You can use the same commands and similar steps to install or downgrade an SAU licensed feature set.

Installing an SAU License

The examples in the following steps show how to upgrade from a 2X10G license to a 4X10GR license on a RUCKUS ICX 7150.

NOTE

In order to perform the following task, you must have ordered and generated a license CoE on the RUCKUS Support site. To verify the licenses installed on the device you must supply a unit number and the purchased license name. The CoE serial number is optional.

1. (Optional) Enter the show license command to verify the licenses already installed on the device.

Downgrading an SAU License

The examples in the following steps show how to downgrade from a 4X10GR license to a 2X10G license on a RUCKUS ICX 7150.

NOTE

When performing a license downgrade, the licensed features continue working until you reload the device.

1. (Optional) Enter the show license command to verify the licenses already installed on the device.

4. Enter the **show version** command to verify the license to which you have downgraded. The Current License field displays the license you have currently installed on the device.

Upgrading Licenses for a Stack

Licenses for members of a stack can be managed from the active controller.

License updates for stack members can be entered from the active controller. As with standalone devices, the **license install perpetual** command is used to update licenses on a stack. Licenses can be installed on each stack member by referencing its stack unit ID in the command. The updates are retained and applied by the individual stack member, and related information is then shared with the active controller. If a stack unit is nonoperational, license updates are applied when the unit returns to active mode. If a stack member goes down, it retains its own license information, but the active controller does not retain it.

The active and standby controllers for the stack store and sync license information. License information is retained during controller switchover or failover. When a device joins the stack, its license information is synced to the active and standby controllers.

An ICX 7150 and ICX 7250 must have a PoD license installed to join a stack because the minimum speed for ICX stacking ports is 10 Gbps. A PoD license must be installed on a port before it can be upgraded to 10 Gbps.

NOTE

ICX 7150-48ZP devices are an exception because they are shipped with two pre-installed 10-Gbps ports.

In an ICX stack, Layer 3 Premium features can be enabled if all units in the stack have a Premium license installed. If a Layer 3 Premium feature is enabled, any unit that joins the stack without a Premium license becomes non-operational. Either the Premium feature must be disabled, or the unit must be upgraded with a Premium license to become operational.

Viewing the Serial Number of the Device

RUCKUS devices that ship during and after the release of software licensing have the license ID (LID) imprinted on the label affixed to the device.

Use the **show version** command to verify the serial number, software and hardware license package name, and the LID of all units in the device. The following example is sample output from an ICX unit with the L3-PREM-2x10G package installed on unit 1 and L3-PREM-8x10G installed on unit 2.

To display general information about all software licenses for all units in a device, use the **show license** command. The **show license** command displays only software license information for a unit, but not hardware license information.

Deleting SAU and XML Licenses from an ICX Device

A license remains in the license database until it is deleted. If you want to delete an SAU or XML license, RUCKUS recommends that you first disable the licensed feature before deleting the associated license.

1. From the privileged EXEC mode, enter the license delete perpetual command to delete an SAU license and restore the default license option.

device# license delete perpetual 1 13-prem

2. To delete all license files for a specific unit, enter the following command at the privileged EXEC level of the CLI.

device# license delete unit 3 all

In this example, all the licenses for unit 3 are deleted.

3. Use the **show license unit** command to display the index numbers.

NOTE

On the ICX 7450 and ICX 7250 devices, if more than one non-node locked license file is installed, the deletion of the license file sequence must begin from the software license file identified by index 1. If this is not done, any attempt to delete the license file returns an error: 141 (LICENSE IN USE).

Transferring a License

SAU licenses can be transferred from one RUCKUS device to another RUCKUS device if the license is being transferred between two similar models (for example, from an ICX 7250 to another ICX 7250 or from an ICX 7450 to another ICX 7450).

A license transfer is intended for retrieving licenses from defective units. The licenses are removed from the defective unit within the support database and the unit is flagged as removed from service.

You can transfer an SAU license without assistance from RUCKUS Support staff (this type of license is not locked to a specific device). To transfer an SAU license, you must disable the feature associated with the license on the original device before you transfer the license to another device.

Layer 3 Premium Features and Platform Support

A Ruckus FastIron Layer 3 Premium license enables Layer 3 Premium features to be configured on an ICX switch.

In a stacking system, the Layer 3 Premium features can be enabled if all units in the stacking system have the premium license. If a Layer 3 Premium feature is enabled, any unit without a Layer 3 Premium license will go into a non-operational state when the unit is added to the stack. This unit will become operational if the Layer 3 Premium feature is disabled or if the Layer 3 Premium license is enabled on that unit.

Ports on Demand Overview and Platform Support

Ports on Demand (PoD) enables a 1-Gbps port to be upgraded to a speed of 10-Gbps. Licensing for Ports on Demand is available on the RUCKUS ICX 7150 and RUCKUS ICX 7250 devices.

To upgrade the port speed, you must first upgrade the license using the **license install perpetual** command, and then configure the port speed to 10 Gbps. To install the PoD license, refer to Installing and Downgrading SAU Licenses on page 26. To upgrade the ports from 1 Gbps to 10 Gbps, refer to Configuring PoD on an interface on page 40.

Ports on Demand Licensing on the ICX 7150

RUCKUS ICX 7150-48ZP devices are shipped with two 10-Gbps ports (1/2/1 and 1/2/3). By default, ports 1/2/1 and 1/2/3 on RUCKUS ICX 7150-48ZP devices are 10-Gbps ports that do not require a PoD license (although Layer 3 Premium features are not included). Additional 10-Gbps ports require a PoD license. The PoD ports on RUCKUS ICX 7150-48ZP devices are ports 1/2/2 and 1/2/4 through 1/2/8.

On other 24-port and 48-port models of the RUCKUS ICX 7150, the PoD ports are 1/3/1 through 1/3/4. On the RUCKUS ICX 7150-C12P and RUCKUS ICX 7150-C12P model, the PoD ports are 1/3/1 and 1/3/2.

NOTE

Ruckus ICX 7150-C08P models do not require Ports on Demand License.



Ports on Demand Licensing on the ICX 7250

The ICX 7250 device has eight ports (ports 1/2/1 through 1/2/8) that can be upgraded to 10-Gbps speed. To upgrade the ports, you must purchase one or more PoD licenses. The number of licenses you need depends on the number of ports that you want to upgrade:

- To upgrade the two default stacking ports (port numbers 1/2/1 and 1/2/3), you need the 2-port capacity PoD license, part number ICX7250-2X10G-LIC-POD.
- To upgrade the eight PoD ports (ports numbers 1/2/1 through 1/2/8), you need the 2-port capacity PoD license *and* the 8-port capacity PoD license, part number ICX7250-8X10G-LIC-POD.

NOTE

Although the ICX7250-8X10G-LIC-POD license is referred to as an 8-port capacity license, it cannot be used by itself to upgrade all 8 ports to 10 Gbps. The 8-port capacity license enables you to upgrade the 6 remaining ports on the device to 10-Gbps speed.

Upgrading a PoD License

Upgrading a PoD license involves the following high-level steps.

- 1. Log in to the Ruckus Support portal to generate the license CoE you need.
- 2. Install the PoD license on the device. Refer to Installing and Downgrading SAU Licenses on page 26 for detailed steps.
- 3. Upgrade the ports to 10-Gbps speed. Refer to Configuring PoD on an interface on page 40 for the steps to complete the upgrade.

NOTE

When the device boots up, the running configuration displays the ports at speed-duplex 1000-full.

4. Use the **show license** command to confirm that the license was installed correctly. The command output shows the license capacity in the Ports field and the license name in the Lic Name field.

If the **speed-duplex 10g-full** command fails because of a licensing issue, one or more syslog messages are automatically generated. A licensing issue can occur because no license is installed on the device or you have incorrectly installed a license that is not tied to the LID of the device.

The following example shows the output from a device with the 8-port capacity version of the PoD license.

• A syslog is generated informing you about the failure.

SYSLOG: <14>Jul 31 00:33:46 10.20.147.22 PoD: No license present for port 1/2/1.

A system message made up of individual syslog errors is generated that gives details about each port.

If you delete a PoD license (either the 2-port or 8-port capacity license), the affected ports continue working at 10-Gbps until you reload the device. When you reload the device, the ports are returned to 1-Gbps speed. For more information about deleting a license, refer to Deleting SAU and XML Licenses from an ICX Device on page 30.

Configuring PoD on an interface

NOTE

Configuring PoD on an interface is supported on RUCKUS ICX 7150 and RUCKUS ICX 7250 ports when upgrading to 10-Gbps speed.

To upgrade the ports from 1-Gbps to 10-Gbps speed, perform the following steps.

- 1. Generate the CoE for the PoD license you want on the Ruckus Support portal.
- 2. Install the SAU PoD license on the device. See Installing and Downgrading SAU Licenses on page 26 for detailed steps.
- 3. Insert the 10-Gbps optic transceiver.
- 4. Enter the speed-duplex 10g-full command on a single interface, multiple interfaces, or an interface range on the ICX 7250.

5. Enter the write memory command to save the configuration. The ports are automatically configured to 10-Gbps speed.

If you enable the port to 10-Gbps speed and then enter the **no speed-duplex** command, the port continues to run at 10-Gbps speed. When the device reboots, the port reverts to 1-Gbps speed.

If the **speed-duplex 10g-full** command fails, a syslog message is generated and displayed. The command fails because there is no license available for the port. The following example is a syslog message generated informing you about the failure.

SYSLOG: <14>Jul 31 00:33:46 10.20.147.22 PoD: No license present for port 1/3/1.

Displaying the license configuration for PoD ports after a license upgrade

The show pod command is used to display the license configuration for PoD ports in a stack after a license upgrade on the ICX 7250.

Campus Fabric Licensing

In a Campus Fabric network, devices configured as port extender (PE) units require the PoD license.

In Campus Fabric (802.1BR or SPX), the ICX 7650 can be configured as the 802.1BR control bridge, and the ICX 7150, ICX 7450, and ICX 7250 can be configured as PE units. To connect to a control bridge over a 1 0-Gbps SPX link, the PE units must have a 10-Gbps PoD license installed. For information about PoD licensing, refer to Ports on Demand Licensing on page 37. In an SPX system, the PoD license is required only on the ICX 7150 and ICX 7250 PE units.

NOTE

The ICX 7150-C08P models do not support Campus Fabric (SPX) system.

The SPX system supports setting an SAU license on the PE unit from the control bridge by using the **license install** command. Refer to Installing and Downgrading SAU Licenses on page 26 for more information.

How MACsec Works

MACsec capabilities prevent Layer 2 security threats, such as passive wiretapping, denial of service, intrusion, man-in-the-middle, and playback attacks.

MACsec protects communications using several configurable techniques. Data origin is authenticated and data is transported over secured channels. Frames are validated as MACsec Ethernet frames. The integrity of frame content is verified on receipt. Frame sequence is monitored using an independent replay protection counter. Invalid frames are discarded or monitored.

Data traffic carried within the MACsec frame is encrypted and decrypted using an industry-standard cipher suite.

How MACsec Handles Data and Control Traffic

All traffic is controlled on an active MACsec port; that is, data is encrypted, or its integrity is protected, or both. If a MACsec session cannot be secured, all data and control traffic is dropped.

When MACsec is active on a port, the port blocks the flow of data traffic. Data traffic is not forwarded by the port until a MACsec session is secured. If an ongoing session is torn down, traffic on the port is again blocked until a new secure session is established.

Control traffic (such as STP, LACP, or UDLD traffic) is not transmitted by an active MACsec port until a MACsec session is secured. While a session is being established, only 802.1X protocol packets are transmitted from the port. Once a secure session is established, control traffic flows normally through the port.

MACsec Key Agreement Protocol

MACsec Key Agreement (MKA) protocol installed on a device relies on an IEEE 802.1X Extensible Authentication Protocol (EAP) framework to establish communication.

MACsec peers on the same LAN belong to a unique connectivity association. Members of the same connectivity association identify themselves with a shared Connectivity Association Key (CAK) and Connectivity Association Key Name (CKN). The CAK is a static key that is preconfigured on each MACsec-enabled interface. MACsec authentication is based on mutual possession and acknowledgment of the preconfigured CAK and Connectivity Association Key Name (CKN).

Each peer device establishes a single unidirectional secure channel for transmitting MACsec frames (Ethernet frames with MACsec headers that usually carry encrypted data) to its peers within the connectivity association. A connectivity association consists of two secure channels, one for inbound traffic, and one for outbound traffic. All peers within the connectivity association use the same cipher suite, either Galois/Counter Mode Advanced Encryption Standard 128 or 256 (GCM-AES-128 or GCM-AES-256), for MACsec-authenticated security functions.

MACsec Key Agreement (MKA) protocol uses the Connectivity Association Key to derive transient session keys called Secure Association Keys (SAKs). SAKs and other MKA parameters are required to sustain communication over the secure channel and to perform encryption and other MACsec security functions. SAKs, along with other essential control information, are distributed in MKA protocol control packets, also referred to as MKPDUs.


MKA Message Exchange between Two Switches

When two MACsec peers confirm possession of a shared CAK and CKN, MKA protocol initiates key-server election.

The key-server is responsible for determining whether MACsec encryption is used and what cipher suite is used to encrypt data. The key-server is also responsible for generating Secure Association Keys (SAKs) and distributing them to the connected device. Once a SAK is successfully installed, the two devices can exchange secure data.

The following figure shows the message flow between two switches during MACsec communication.

FIGURE 13 MKA Pre-shared Key and Key Name Exchange between Two Switches



Secure Channels

Communication on each secure channel takes place as a series of transient sessions called secure associations. These sessions can only be established with a unique Secure Association Key (SAK) assigned to the session.

Secure associations expire and must be re-established after transmission of a certain number of frames or after a peer disconnects and reconnects.

The secure association is designated by a Secure Association Identifier (SAI), formed from the Secure Channel Identifier (SCI) combined with an Association Number (AN). When a MACsec frame is received by a peer interface, the device identifies the session key from the SAI carried in the MACsec frame and uses the key to decrypt and authenticate the received frame.

MACsec licensing

Devices that support MACsec functionality can be enabled for MACsec by purchasing a MACsec license.

There is no license capacity and no trial license associated with the MACsec license. The MACsec license works independently of Premium or PoD licenses already installed on ICX devices. In a stacking system, the MACsec license is required only for the specific units in the stacking system that enable MACsec and use the encryption capabilities at the port level. This MACsec license is not required for other units within the stacking system that do not enable MACsec.

The MACsec feature-related CLI commands are not controlled by the MACsec license. The MACsec preconfiguration commands and enabling commands are visible and available without a MACsec license. However, a valid MACsec license is required for the command to enable MACsec encryption at the port level on that device. When you enter the CLI command to enable MACsec at the port level without a MACsec license, the

command does not execute, and an error message is displayed. The command enables MACsec encryption on that port only when a valid MACsec license is installed on the device.

Enabling and Configuring Group Interfaces for MACsec

After MACsec is enabled for the device, each MACsec interface must be individually enabled, and a configured group of parameters must be applied.

1. To enable MACsec, at the dot1x-mka configuration level, enter the enable-mka command, and specify the interface as unit/slot/port.

In the following example, Ethernet port 1 on slot 2 of unit 2 is enabled for MACsec security.

NOTE

The following output is displayed if there is no MACsec license present on the device.

 At the dot1x-mka interface configuration level, enter the mka-cfg-group command, and specify the MKA group configuration to apply to the interface.

In the following example, MACsec options configured for group test1 are applied to the enabled interface.

ICX License Serial Number Prefixes

The Certificate of Entitlement (CoE) issued for each license purchased includes a unique serial number.

The CoE license serial numbers have the format: PPPRabcdefg. In this format,

- PPP is the Serial Number Prefix, which identifies the type of license
- R is a serial number produced by Ruckus
- abcdefg is a unique number string.

An example CoE serial number is DVVR1234567.

The serial number prefixes are unique to each license type, as shown in the following table.
